

Every year, The Arc honors donors who have reached milestones in their giving, and any individuals who have passed over the previous year at the Honor Tree ceremony. As you can imagine, The Arc uses the imagery and stability of a tree to symbolize the ebb and flow of life and how these forces affect life in the natural world and life within The Arc.

In the book The Giving Tree by Shel Silverstein, a tree gives a boy, what it has to offer, over and over again until it is a stump that the much older boy uses to rest. But trees are much more than these commodities. They give us food and oxygen, help stabilize and cool the environment, enrich the soil, and as many scientists are now discovering - give to and support one another within a forest ecosystem. Many of the services trees provide can't even be measured. Trees and forests give slowly, if we sit back and let them.

Leaving a legacy also fits the analogy provided by trees. However giving in this manner is less like the Giving Tree model of giving commodities (fruit, wood, etc.). They are much closer to giving of services provided by forests (oxygen, clean air, and water). Benefactor forests provide for us defini-tively, providing the services we all depend on in perpetuity.

By including The Arc of the Quad Cities Area in your Will, Trust, or beneficiary designation, you pass on a gift of essential services that support the full inclusion and participation in community life of people with disabilities, now and in the future. These partnerships have enhanced our ability to embed people with disabilities in their community. Like a community based CDS group that starts and ends their day at the Rock Island Fitness & Activity Center. Programs like these are set in the bedrock principal that "we are better together". That our mission, enhanced by partnerships and centered on person centered programming, can and will withstand the upheavals of the previous year and seize on the opportunities that lie ahead.

We are grateful that many of us have the opportunity of being able to get the vaccine as part of the la group. However we continue to plan and advocate for distribution that is fair and equitable for people with disabilities and their caregivers. Most all of the individuals we serve are choosing to get vaccinated. The Arc continues to encourage our staff to also become vaccinated, as this is our best shot to try to get people back into community services. We are all in this together. ## Newly Rehabilitated home in Rock Island Expands Choice

The smell of fresh paint greets visitors to a home under construction on Brittany Lane in Rock Island. Soon this first will be replaced with homey furnishings and the aromas of home cooked meals.

expansive efforts to offer the highest amount of choice in residents for people with disabilities living in the Quad Cities. The opening of this home on Brittany Lane in Rock Island will offer four residents the opportunity to live in their own community with the supports they need to live their best lives.

The home offers an accessible housing option with a ramp, large open communal areas, four private bedrooms, office space and accessible outdoor areas. The home might not look big on the exterior, but once inside you can see the home offers large open, airy rooms

complete with hardwood floors and fresh paint.

"We are proud of our efforts to expand the impression of a home under construction number of housing options in our area that correspond to the demand for smaller, more intimate housing choices" says Michael Glanz, The Arc's Executive Director. "The home at The Arc of the Quad Cities Area has made Brittany Lane is a wonderful offering for families".

> Although the home is still under construction at this time, we anticipate that it will be ready to live in by the spring. The home at Brittany Lane represents an overall shift in residential services toward offerings with small settings. With this home and the other sixteen homes, The Arc is able to offer more choice for residents with four. five, six, seven, and eight bed homes. More choice in residents is another chapter in a story of greater independence for individuals with disabilities. This chapter has been a part of a story that has been unfolding for almost 70 years.

Soon, four individuals will move into this house they will put their own personal stamp it as it becomes their home.






