# Trivia Night

In a statement to the public, all the health care providers in the Quad Cities Area recently announced that cases are continuing to rise and are at rates the highest since November 2020. The home is a four bedroom, three bathroom home that has recently been renovated with a new kitchen and dining space, and updated bathrooms. The home provides comfortable indoor and outdoor living with the addition of a large deck with sliding door. The home is wheelchair accessible.

Brittany Lane is home to four individuals who are loving the new location including the deck which gets sunshine throughout the afternoon hours.

The Arc's residential program provides services for people with intellectual and developmental disabilities with warm, welcoming spaces for anyone to live.

# **Vending Machines to Provide Jobs for People with Disabilities**

Thanks to the support of the Scott County Regional Authority, The Arc of the Quad Cities Iowa will be able to purchase two vending machines that will be the basis for a social entrepreneur program supporting the creation of jobs for people with disabilities living in Iowa.

The Arc of the Quad Cities Iowa has a partnership with Good Will to place these machines in their Bettendorf location. The machines will be serviced by an individual with disabilities, making that individual the first employee of The Arc of the Quad Cities Iowa. Since 1962 The Arc has been an all

volunteer organization. For an organization

that was founded on creating opportunities for people with disabilities, it is profound that the first employee will be a person who embodies that mission. The machines will will continue to further the mission of Goodwill.

The partnership with Goodwill was initiated by The Arc of Iowa. All proceeds from the machines will help support the The Arc of Iowa and The Arc of the Quad Cities Iowa.

# **CARF** Accreditation

#### **Meeting and Achieving High Standards**

The Arc of the Quad Cities Area is kind of a big deal, and we have a seal of approval to show for it. The Arc has received accreditation from the Commission on Accreditation of Rehabilitation Facilities (CARF).

To achieve accreditation The Arc went through a rigorous process to prove its commitment to the community. This accreditation process ensures that organizations are currently meeting high standards as well as constantly improving services and programs.

The Arc underwent an internal examination of its program before requesting an on-site survey conducted by an expert team selected by CARF. The Arc demonstrated to the experts that we follow the rigorous and internationally

recognized CARF standards. The Arc also submitted a Quality Improvement Plan to CARF to commit to

improving the areas that need to be improved.

The highest CARF accreditation is a three year award, and The Arc has received the highest level each application year. The CARF seal of approval goes beyond a competitive distinction for providers like The Arc. It provides a sign of quality for persons served that The Arc is committed to encouraging feedback, continuously improving services and serving the needs of the disability community. That is the real value of accreditation - and it's kind of a big deal.

# Innovation Through Inclusion

At The Arc, we are driven by a mission of a more inclusive world for everyone. Fulfilling this vision requires passion and diversity of skills and backgrounds. More and more employers are finding that hiring people with disabilities is a good choice. Some employers have known and benefited from the work of people with disabilities for some time.

The Butterworth Center & Deere-Wiman House in Moline, Illinois is one such employer. The property is operated by the William Butterworth Foundation and serves as a year-round site for quality education, cultural events, and a free meeting space for non-profit organizations. In order to host the community, the organization relies on dedicated staff to ensure that the property is not only clean and orderly, but the rooms meet the guests' specifications.

Meet Taylor Apple, a seasoned Community Relations Representative. Taylor has been working for the Butterworth Center & Deere-Wiman House for six and a half years. He

started as a housekeeper and later shifted to working with community groups. He has slowly added on to his repertoire of responsibilities. Now he supports community groups utilizing the space. Ensuring that the Smart-TV settings are in-place, the microphones are turned on, and projectors are ready per each guest's specifications for virtual meetings are some of the things Taylor

does regularly.

A housekeeper's duties on a historic home filled with priceless antiques can be immense. One of Taylor's first duties as housekeeper was checking the floor for broccoli after a recital. Obviously, leaving broccoli behind on an antique rug or hardwood floor could cause permanent

damage and be deadly to the nostrils if left unchecked. In the home's heyday, there would have been a small army of people to make sure the home's occupants had every need not only met but, anticipated. Now the home serves as a community space that is well known and utilized by thousands of people each year. Taylor and the entire staff at Butterworth, work together with flexibility and good humor to meet the diverse needs of their guests and make the space welcoming for all.

# Program Expansion

#### Land in Silvis Will Be Site Location of Job Training Center

People helping people – it's the foundation of all credit unions and the cornerstone of IHMVCU's mission to improve the financial well-being of our members, team members and the communities we serve. It's with this idea in mind that IHMVCU is pleased to announce the donation of roughly 10 acres of land located at 1801 Crosstown Avenue in Silvis to The Arc of the Quad Cities Area.

"It was the perfect storm," said Rick Schloemer, IHMVCU Community Outreach Coordinator and Community Funding Committee Chair. "We had land looking for a new home and The Arc was looking for land for a new initiative."

The Arc's goal with the land is to create a selfsupporting social enterprise that will provide job opportunities and training for people with disabilities who are looking for job experience, specifically in agriculture and horticulture.

"This donation from IHMVCU is just the right catalyst to allow The Arc to support people with disabilities by expanding their potential through employment. This unique opportunity will help us to build a new pathway to guide people with disabilities while they find success on their life journey, just like IHMVCU helps their members find success on their financial journeys" said Michael Glanz, The Arc of the Quad Cities Area Executive Director.

The land will expand The Arc's services to support individuals with disabilities to transform their lives through job training development, career growth, community integration, horticultural therapy, and increased financial autonomy. Individuals will gain the soft skills, technical instruction that they need to work in horticulture, agriculture, or a career of their choosing followed by job assistance. placement and job coaching. The land is located adjacent to Walmart on Crosstown Avenue in Silvis.
